- 5. Discuss Tax Rate Recommendation from the District's Financial Advisor;

- 7. If timely, consider and adopt Order Setting Tax Rate for 2022 and authorize necessary filings;
- 8. Hear report from developer on status of development, and if necessary, take action on possible amendments or assignments of the Agreement for the Construction and Purchase of Facilities and Reimbursement for Costs, or any additional actions as may be necessary;

Hear report from engineer, review of any bids received and recommendation letter from engineer as to award of contract, status of contract awards, authorizations for additional contract advertisements, review and approvals of any needed plat approvals, pay applications or change orders under existing contracts, partial or final acceptance of any projects, approve any necessary easements, assignment of easements, encroachment agreements or assignments thereof, or conveyance of facilities, review and approve any recommendations for maintenance and improvement projects and related matters and take necessary action with respect thereto;
- 10. Discuss and consider a Resolution Adopting Prevailing Wage Rate Scale for Construction Projects, and any filing as may be necessary with regard thereto;
